## Important OSHA Standards Contributing to Fewer Workplace Accidents



Standard 1910.132  
**Personal Protective Equipment:** Protective equipment, including clothing, helmets, goggles and other eye protection, must be used when process or environment presents hazards that could cause bodily harm.



Standard 1910.147  
**Lock Out-Tag Out:** The employer must prohibit the operation or startup of machinery, equipment or systems until the release of hazardous energy during the servicing or maintenance of the equipment with the lockout/tagout procedure and 30,000 workers each. (Source: OSHA)



Standard 1910.119  
**Process Safety Management (PSM):** Put in place in 1992 to prevent a major unplanned release of a highly reactive, flammable, or toxic substance, PSM has reduced the number of fatalities and injuries that result from major releases of such substances. (Source: OSHA)

**OSHA Inspections:** OSHA inspectors conduct workplace safety and health inspections to ensure that employers are complying with OSHA standards. OSHA inspectors are trained to identify and correct safety and health hazards in the workplace. OSHA inspectors are also trained to investigate and cite violations of OSHA standards. OSHA inspectors are also trained to conduct safety and health training for employers and workers.

Process Safety Management Standard follow the concepts embodied in the OSHA training guidelines contained in this booklet The length and complexity of OSHA standards may make it difficult to find all the references to training So to help employers safety and health professionals training directors and others with a need to know OSHA s training related requirements have been excerpted and collected in this booklet Requirements for posting information warning signs labels and the like are excluded as are most references to the qualifications of people assigned to test workplace conditions or equipment It is usually a good idea for the employer to keep a record of all safety and health training Records can provide evidence of the employer s good faith and compliance with OSHA standards Documentation can also supply an answer to one of the first questions an accident investigator will ask Was the injured employee trained to do the job Training in the proper performance of a job is time and money well spent and the employer might regard it as an investment rather than an expense An effective program of safety and health training for workers can result in fewer injuries and illnesses better morale and lower insurance premiums among other benefits
